

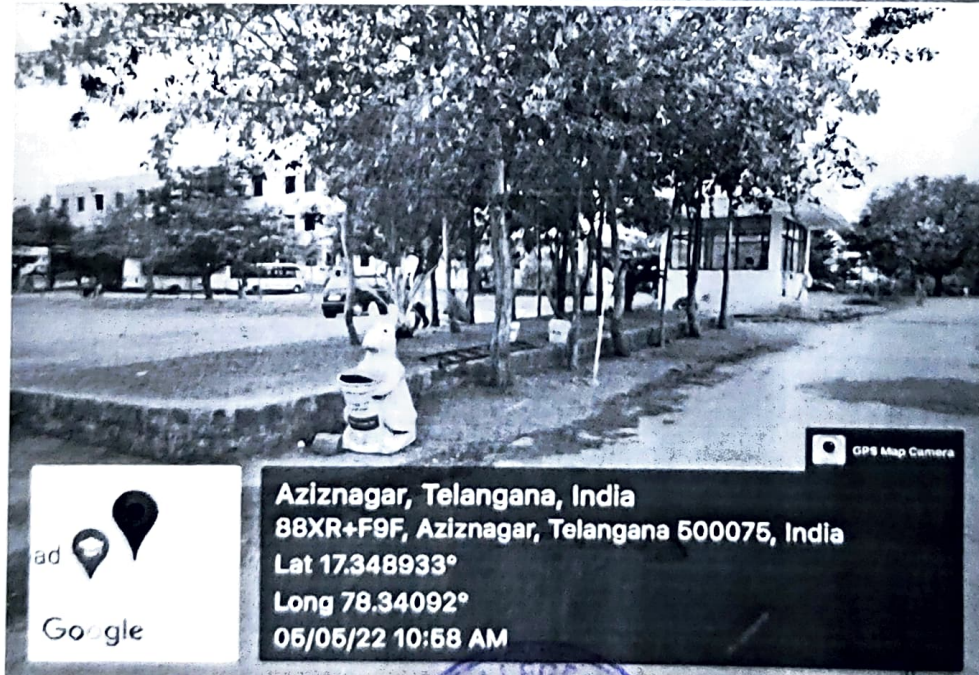

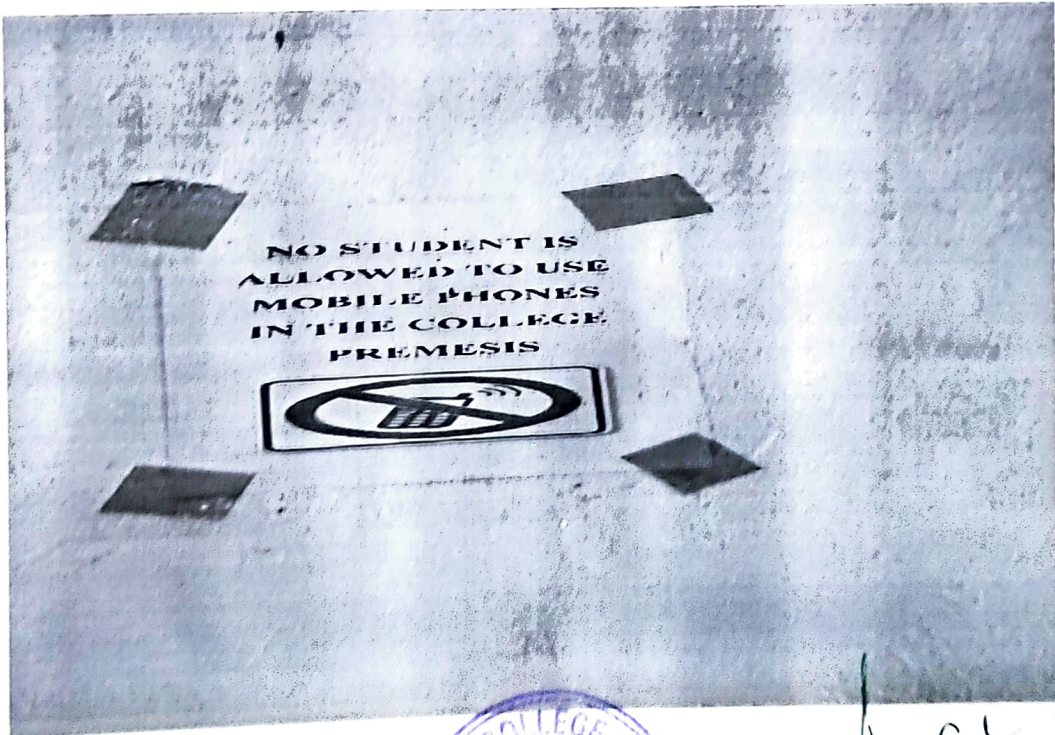
## TREES AND PLANTATION
